Commission. Fees and Sales Tax

A consignment fee of 30% of the selling price will be retained by Boathouse Treats & Treasures on all cash sales. A 33% commission will be retained by Boathouse Treats & Treasures on all credit card sales. Sales tax requirements will be discussed with each consignor. Legal businesses are required to collect sales tax by state law. Items will be automatically discounted as follows.

- 1 2 months Item will not be discounted unless the consignor agrees to an offer.
- 3 4 months Item will be marked 25% off the initial price.
- 5 6 months Item will be marked 50% off the initial price.

Six months to the day after the date of the initial consignment, item(s) must be removed from the shop or it/they become the property of Boathouse Treats & Treasures.
